Purpose. The 5-Year and Annual PHA Plans provide a ready source for interested parties to locate basic PHA policies, rules, and requirements concerning the PHA's operations, programs, and services, and informs HUD, families served by the PHA, and members of the public of the PHA's mission, goals and objectives for serving the needs of low- income, very low- income, and extremely low- income families

Applicability. Form HUD-50075-HP is to be completed annually by **High Performing PHAs**. PHAs that meet the definition of a Standard PHA, Troubled PHA, HCV-Only PHA, Small PHA, or Qualified PHA do not need to submit this form.

Definitions.

- (1) **High-Performer PHA** – A PHA that owns or manages more than 550 combined public housing units and housing choice vouchers, and was designated as a high performer on both of the most recent Public Housing Assessment System (PHAS) and Section Eight Management Assessment Program (SEMAP) assessments.
- (2) **Small PHA** - A PHA that is not designated as PHAS or SEMAP troubled, or at risk of being designated as troubled, and that owns or manages less than 250 public housing units and any number of vouchers where the total combined units exceeds 550.
- (3) **Housing Choice Voucher (HCV) Only PHA** - A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment, and does not own or manage public housing.
- (4) **Standard PHA** - A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceeds 550, and that was designated as a standard performer in the most recent PHAS or SEMAP assessments.
- (5) **Troubled PHA** - A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) **Qualified PHA** - A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined, and is not PHAS or SEMAP troubled.

**This Notice restates the waivers and alternative requirements included previously in Notice PIH 2020-13, carries forward information on previously specified HUD actions, adds new waivers and alternative requirements, and incorporates the waivers and alternative requirements for Mainstream vouchers and the Mod Rehab Program. In addition, this Notice extends the period of availability of certain waivers, such as those related to Income Verification and Annual Examinations, until June 30, 2021.

NOTE: HQS inspections resumed June 1, 2020 with all postponed inspections completed prior to 10/31/2020. One inspection was done remotely as a reasonable accommodation for a person with a disability.

Apply for additional rental vouchers to serve the growing waiting list in the ten-county region. – There was no opportunity to do so in 2020. 2. Leverage private or other public funds to create additional housing opportunities. – We continue to partner with Missouri Department of Mental Health as processing center for 2 Shelter Plus Care grants. 3. Achieve 100% utilization of HUD Section 8 HCV Budget Authority to assist the maximum number of households authorized under the HUD ACC which is 588 units. We achieved 97.6% and we will continue to strive to the goal of 100%. 4. We continue to be the Processing Center for HUD Shelter Plus Care program with Missouri Department of Mental Health as the HUD Grantee. 5. Strive for 100% score on HUD SEMAP. Always! 6. Maintain high customer satisfaction through timely processing of tenant applications and HAP Contracts with Owners. Due to COVID-19 we are completing paperwork by mail and have experienced some delays in mail delivery. The Board approved a 5 business day grace period for missed deadlines and we check postmark dates to see if participants mailed the forms on time we should have received the information by the deadline. 7. Keep the Housing section of the OACAC website updated with information of interest to both tenants and property owners. Ongoing. 8. Maintain supervisor Quality Control measures to maximize program performance and reduce processing error. Ongoing 9. Continue aggressive housing quality enforcement. We postponed annual inspections for 2 months at the onset of the COVID-19 stay at home order but resumed in-person HQS inspections June 1, 2020. Initial inspections for participants coming on our program or moving to a different unit were performed all along. Some inspections were postponed due to participants need to quarantine due to contracting the virus or self-quarantine due to exposure to the virus. Inspectors followed CDC guidelines where possible to prevent the spread of the virus. 10. Continue aggressive enforcement of Family and Owner responsibilities. We investigate reports of possible fraud and watch for irregularities in information provided that may warrant investigation. 11.
