- (3) Housing Choice Voucher (HCV) Only PHA A PHA that administers more than 550 HCVs, was not designated as troubled in its most recent SEMAP assessment and does not own or manage public housing.
- (4) Standard PHA A PHA that owns or manages 250 or more public housing units and any number of vouchers where the total combined units exceed 550, and that was designated as a standard performer in the most recent PHAS and SEMAP assessments.
- (5) Troubled PHA A PHA that achieves an overall PHAS or SEMAP score of less than 60 percent.
- (6) Qualified PHA A PHA with 550 or fewer public housing dwelling units and/or housing choice vouchers combined and is not PHAS or SEMAP troubled.

	The PHA has set payment standards at 105% for all bedroom sizes in and all counties except Christian, Greene, Stone, Taney and Webster Counties. The payment standards are set to reduce the rent burden for the program participants and help searchers with vouchers find a home within program guidelines. The 2025 utility allowance survey was completed and the UA schedule adjusted for the upcoming year. Increases were in Water, Sewer and Trash Services for all bedroom sizes.

	 Apply for additional rental vouchers to serve the growing waiting list in the ten-county region. We applied for FYI vouchers and accepted the offer of EHV and TP/EH Opt-Out vouchers. We were awarded an additional 14 Fair Share vouchers in October, 2022.
	2. Leverage private or other public funds to create additional housing opportunities. We continue to partner with Missouri Dept. of Mental Health to be the processing center for 2 Shelter Plus Care grants in our service area.
	3. Achieve 100% utilization of HUD Section 8 Housing Choice Voucher Budget Authority to assist the maximum number of households authorized under the HUD ACC which is now 619 units. It has been a challenge to keep up with attrition during 2023-2024 due to the lack of available rental housing and affordable rental housing in the 10 counties we serve.
	4. Continue to administer HUD Shelter Plus Care voucher program funded by Missouri Department of Mental Health. On-going partnership.
	5. Strive for 100% score on the HUD Section 8 Management Assessment Program (SEMAP). Our PHA achieved a 100% score for our FY2023. We always strive to keep our High Performer status.
	 Maintain high customer satisfaction through timely processing of tenant applications and Housing Assistance Payments Contracts with owners. Our PHA meets in person for all appointments unless due to disability reasonable accommodation requests or proof of extended illness.
